## Utah Board of Pardons

Inmates who have been incarcerated for certain criminal offenses may be eligible for parole, which is early release from prison. Parole is granted by the Utah Board of Pardons and Parole (BOPP) on a case-by-case basis. The Board of Pardons and Parole schedules a hearing with the inmate to examine his or her eligibility for early discharge.
