


# Product Liability Lawyer in Utah for Defective Products

## What is Considered a Defective Product?

The legal definition of a defective product is **a consumer product that has an imperfection due to an error in design or manufacturing or is faulty because of inadequate consumer warnings or user instructions**. Defective products can be any commercially available item available for purchase by an individual consumer from companies who manufacture and/or sell packaged goods, beverages, electronics, prescription and OTC medication, food production, automobiles, toys and more. A product's defective condition can result from many different things, including:

- Design Flaw
- Manufacturing Error
- Improper Labeling
- Insufficient Instructions
- Malicious Intent
- Poor Judgement
- Human Error

## The Three Types of Product Liability Claims

---

While there are many different reasons a product may be defective, there are three types of claims for defective products. ***The manufacturer is liable for negligence at every stage of the product's development, production and release.*** Consumers can file a claim based on one of the following three reasons for defective and dangerous products causing property damage, injury or death:

### 1. Design Defects

Harm or injury resulting from a poorly-designed product or the designer's failure to address all possible risks in a product's design and intended use.

### 1. Manufacturing Defects

Property damage, injury or death caused by poor quality materials, improper assembly and careless quality control during the manufacturing process.

### 1. Marketing Defects

Injury or harm caused by improper or confusing instructions or a manufacturer's failure to warn consumers about a possible safety hazard.

## Common Defective Product Cases

---

- Battery Fires (cell phones, hoverboards, etc.)
- Defective Baby and Child Products (car seats, highchairs, etc.)
- Defective Medical Devices (metal hip replacements, stents, etc.)
- Defective Automotive Products (airbags, seatbelt failure, etc.)
- Defective Consumer Products (recreational products, firearms, etc.)

- **Punitive Damages** awarded by the court as a punishment for a manufacturer's negligence.
