# The Consequences of Sex Offense Convictions in Utah

The punishment for a sex crime conviction in Utah can be severe. Mandatory minimum sentences for serious sex crimes are described in Utah Cod. Ann. § 76-3-406. Under this law, "probation may not be granted, the execution or imposition of sentence may not be suspended, [and] the court may not enter a judgment for a lower category of offense" for the following offenses:

- Child kidnapping;
- Rape;
- Forcible sodomy;
- Forced sexual abuse;
- Aggravated sexual abuse of a child;
- Aggravated sexual assault; and
- Attempt to commit rape of a child.

Even less serious sexual offense convictions can have severe and long-term consequences. The Utah Predatory Offender Registration Law requires individuals who have committed certain sex crimes to register as sex offenders. These crimes include those listed above, as well as lesser crimes, such as criminal sexual predatory conduct, enticing or soliciting a minor to perform sexual acts or prostitution, incest, possessing child pornography, and felony indecent exposure.
